## **About**

The Dun Laoghaire Rathdown Public Participation Network (DLR PPN) is the umbrella network of Community & Voluntary, Social Inclusion and Environmental groups in Dun Laoghaire-Rathdown. Our membership is diverse and includes local community and volunteer groups such as active retirement groups, men's sheds, residents' associations, scout and guide groups, chess and bridge clubs, sporting, as well as environmental and social inclusion organisations operating in DLR county.

We provide our member groups with opportunities for networking, learning, communication and sharing of information which leads to participation in local decision making and collective action. For example, we provide free training open to all our members in areas such as digital skills & technology, governance, committee skills, funding and more. We run regular workshops, linkage groups and public consultation meetings to ensure that our members' voices are heard. We enable the community to elect representatives to sit on the local government committees which cover these policy areas: Community, Culture & Wellbeing, Economic Development and Enterprise, Environment and Climate Action, Housing, Planning and Transportation and Marine Strategic Policy Committees and the Local Community Development Committee.

#### Our aims are:

- To facilitate communication between community groups and DLR County Council. To give voice to a diverse range of views and interests within the local government system and participate in policy making.
- To strengthen the ability of people, groups, and organisations to contribute in a positive way to the community in which they reside or are active within.
- To act as an information hub for local community and voluntary, environmental and social inclusion groups and organisations.
- To actively support the local community during challenging times such as the pandemic as a member of the local Community Stakeholder Forum.

Membership is free to groups in the Dun Laoghaire Rathdown area who fulfil the membership criteria. All ages and abilities are welcome. Further information: www.dlrppn.ie or email enquiries@dlrppn.ie

The DLR PPN is overseen by a Secretariat of 9 members elected by full member groups of the network. The Public Participation Network elects representatives to committees and organisations to speak on behalf of all member groups of the network.

For this purpose, the DLR PPN identifies issues that matter and tries to influence policy in a way that improves the quality of life and opportunities for people within the Local Authority area of Dún Laoghaire Rathdown.

The DLR PPN is the main link through which Dún Laoghaire Rathdown County Council and other decision-making bodies in the Dún Laoghaire Rathdown County Council area connect with the community and voluntary, environmental and social inclusion sectors.

## **DLR PPN Staff Report**

The year 2021 started against the continued backdrop of Covid restrictions. As it moved forward and we availed of the vaccination programme, we saw an easing of restrictions and became more hopeful that we could return to a new normal in our daily lives.

We received a great response to our training programmes, in particular the Digital Skills for Beginners Programme which was implemented as a direct result of the needs identified by DLR PPN members who participated in our Digital Skills Survey 2020. The programme was run as a collaboration between the DLR PPN and dlr County Council.

In the autumn we began a major project, the Vision for Community Wellbeing Statement for Dun Laoghaire Rathdown. We sought the opinion of our members and the wider community in Dun Laoghaire Rathdown by asking "What Vision do you have for our Community, for now, and for Future Generations?" at workshops and through our online survey. As soon as this phase of the consultation was completed, we applied ourselves to the task of compiling and categorising the data. We are pleased to say that when the final Draft Consultation period was completed in the spring of 2022 the Vision Statement will be brought to the Plenary for ratification. Once again we sincerely thank all those who participated by taking the time to complete the survey and attend the workshops, without your participation none of this would have been possible.

We wish to take this time to thank our DLR PPN membership for their continued participation and support in 2021 and to acknowledge the importance of the work of Community and Voluntary groups in the Dun Laoghaire Rathdown Community.



# What Vision do you have for our Community, for now, and for Future Generations?

The Vision for Community Wellbeing For This and Future Generations identifies the key issues that member groups in the DLR PPN area consider are important for their community to be "The best that it can be for this and future generations".

The Vision Statement will act as a guiding vision for everything done by this network. It will be a benchmark for DLR PPN Representatives and the Secretariat – feeding into policy decisions and planning activities.

In autumn 2021, we began the consultation process and asked our membership and the wider DLR community to share their vision for the DLR community for now and future generations.

We held 9 workshops with over 70 participants, we also asked you to make submissions to the Vision For Community Wellbeing Survey to which we received over 330 responses.

The data collected from both the workshops and submissions is being collated to create the Draft Vision Statement. This data is collated according to the six themes, Health (Physical & Mental); Economy and Resources; Social & Community Development; Participation, Democracy & Good Governance; Values culture & Meaning and Environment & Sustainability (see graphic above).

These themes will then be subdivided into sub-category, which include:

- Environment/ Nature/ Parks
- Community meeting places
- Community
- Sport activities
- Art activities
- Intergenerational resources
- Housing
- Transport and roads
- Climate change
- Community supports

The feedback from each theme will be summarised to create the draft statement.

We scheduled a final consultation period for the spring of 2022 to seek feedback on the Draft Vision Statement, by holding additional workshops and seeking further submissions. Once the final statement is created it will be given to the Plenary for ratification.

We wish to thank everyone who participated to date and we look forward to receiving your feedback on the Draft Vision in the near future. We also want to thank dlr County Council for their collaboration on this project.
