### **About**

Dún Laoghaire Rathdown Public Participation Network is the collective voice for community and voluntary, environmental and social inclusion organisations in Dún Laoghaire Rathdown. Its purpose is to improve people's well-being by involving the community in local decision-making.



Dún Laoghaire-Rathdown Public Participation Network (DLR PPN) is an independent umbrella network of community & voluntary, environmental and social inclusion groups active within the county. Public Participation Networks (PPNs) were established by the Irish Government under the Local Government (Reform) Act 2014 to be the main link through which the Local Authority connects with community & voluntary, social inclusion and environmental groups.

Government guidelines outline 3 main objectives for PPNs:

- ☐ Facilitate the participation and representation of communities and policy making bodies through the community and voluntary, social inclusion and environmental sectors.
- ☐ Strengthen the capacity of communities to contribute positively to the community in which they reside or participate.
- ☐ Provide information relevant to the community and voluntary, social inclusion and environmental sector and act as a hub around which information is distributed and received.

The DLR PPN identifies issues that matter and tries to influence policy in a way that improves the quality of life and opportunities for people within the Local Authority area of Dún Laoghaire Rathdown.

The DLR PPN is overseen by a Secretariat of 9 members elected by full member groups of the network. The Public Participation Network elects representatives to committees and organisations to speak on behalf of all member groups of the network.

The DLR PPN is the main link through which Dún Laoghaire Rathdown County Council and other decision-making bodies in the Dún Laoghaire Rathdown County Council area connect with the community and voluntary, environmental and social inclusion sectors.

### **Secretariat Report**

As with all society, the Secretariat has had a challenging year. DLR PPN is fortunate to have volunteer members who are willing to give the time to support the Network Manager and Support Worker, whose workload increased enormously as the year progressed.

The Secretariat held monthly meetings which were well attended. Several other meetings per month were required as the PPN workload increased, and the expertise among Secretariat members proved invaluable.

The Secretariat was very conscious of the need to fully support the Network Manager and Support Worker as they navigated the challenges of an unconventional year. They came through magnificently.

Some of the highlights and achievements of 2020 were:

Adapting to use new technologies to ensure that the work of the DLR PPN continued during restrictions.

The Residents Association Survey - This provided an insight as to the community's response to the Covid situation and where supports were needed. The results of this and the Funding Requirements survey helped to inform and shape the response to the covid emergency. "A Case Study of Dun Laoghaire Rathdown Residents Associations Response to COVID-19 - Public Participation in Times of Crisis" was presented at the Martin McEvoy Annual Conference 2020.

Training - New training programmes were developed in response to the needs of the DLR community. It became clear that while many readily embraced the use of technology to communicate and source information during lockdown some members of the community were being left behind, mindful of this a new programme of training was developed to address these issues. It included Zoom for Beginners and Zoom Intermediate for example. The Spring Training Programme 2021 has been developed as a direct response to the training needs expressed in the DLR PPN Community Wellbeing Survey. A further programme, Digital Skills for Beginners will be rolled out in 2021.



# **Membership**

Membership of the DLR PPN is open to all community and voluntary groups, clubs and organisations in Dún Laoghaire Rathdown, working on a voluntary, co-operative or not-for-profit basis for the benefit of the community.

The total number of DLR PPN membership groups after the re-registration process finished is 487. The number of groups that did not complete the re-registration process was 75. In 2020 we were joined by 48 new member groups. 42 from the Community Pillar and 6 from the Social Inclusion Pillar.

#### Radio Programme

**Cuala GAA**, and their participation in the Musgrave/GAA Club Together Initiative, assisting vulnerable members of the community during the COVID 19 pandemic.





### **Building Capacity**

In order to strengthen the capacity of communities and of the environmental, social inclusion community and voluntary groups to contribute positively to the community in which they reside/participate we organised training, events, presentations and linkage groups. As the year progressed these events were moved to online platforms in adherence to Covid-19 restrictions.

#### **Training**

We held 10 training sessions for DLR PPN members with more than 230 attendees. During the first quarter these sessions were conducted in local venues however these had to move online as the year progressed.

The online training workshops were organised based on feedback received from our members who participated in the Residents Associations Response to Covid 19 and the Community Wellbeing surveys and covered the following topics:

Email Marketing Zoom Intermediate

We collaborated with DLR CoCo to produce Youtube training videos, Zoom Beginners Part 1 & Part 2 covering the topics of how to open an account, schedule a meeting and host a meeting.

#### <u>Plenary</u>

The Plenary meeting arranged for April 2020 had to be cancelled due to Covid restrictions. We did hold one Plenary meeting online with more than 40 members attending in November 2020.

## **Community Well Being - Response to Covid 19**



Our response and activities were influenced by three main factors:

- Government directives
- ☐ Ongoing and precious feedback from our local community groups about specific needs arising (contacted by phone, email, messages, etc.)
- ☐ Close collaboration with Community Call Stakeholder forum

We focused strongly on communication with our members, prioritising research to help inform stakeholder decisions and providing ongoing support. We did this by:

- ★ Creating a separate web page at the very beginning of the crisis on our website with useful resources. <a href="http://dlrppn.ie/covid-19/">http://dlrppn.ie/covid-19/</a>
- ★ Regular news updates posted on our website about funding, local initiatives, online resources, and much more.
- ★ Social media posts sharing the news and the DLR Helpline (Facebook and Twitter) multiple times each week.

- ★ Weekly emails to our membership about updates, services and supports available.
- ★ Text message to Residents Association promoting the DLR Helpline.
- ★ Two DLR PPN Ezine Newsletters sent to all members (March 2020 and April 2020). For the April issue, we asked groups and communities to send news of how they were responding in order to highlight the vibrant response in our community and the response has been fantastic.
- ★ Radio programmes Community Connections interviews with relevant local organisations providing support.
- ★ Communication by phone we rang all Residents Associations and Estate Management companies on our database (almost 100 in total) to inform and obtain feedback.

#### **DLR Residents Associations Report**

We contacted all Residents Associations in order to get a snapshot of the response happening at local level, with very interesting and relevant results - please see Residents Associations in DLR Respond to the Covid-19 Crisis on <u>dlrppn.ie</u>. The results were widely distributed to local stakeholders.

We asked the local groups to give us feedback on the needs that they saw as arising from the COVID-19 crisis. Please see Report on What DLR Groups Identify as funding needs. This helped inform the dlr County Council's funding Guidelines for the COVID-19 Emergency Fund and the Community Wellbeing Initiative.



Through this research, as well as through the regular contact with different communities by phone, we were able to sense a change of mood and adapt our communication to respond to this change. We researched and shared information on Health and Wellbeing, resources to assist Cooconers and the Helplines available. Our post Online Hobby and Cultural Resources was very well received.


- 1. We have been a member of the Forum since the beginning, attending all meetings and providing vital feedback on the response at the local level, thanks to our research and the feedback obtained.
